26th Asian Tenpin Bowling Championships Selection Criteria, Minimum Requirements, Selection Mechanism, Appeal Mechanism for Nomination Procedures set by Hong Kong Tenpin Bowling Congress Limited

Introduction

26th Asian Tenpin Bowling Championships is schedule to be held in Hong Kong, China from January 8 – 18, 2023. Events include Singles, Doubles, Trios, Team of 5, Masters and All Events. A maximum of 6 athletes will be selected for the Men Team and Women Team respectively.

Selection Criteria and Minimum Requirement

1. Current HKSI Full Time Athlete or Part-Time Junior Athlete since year 2019
2. Take part in the Selection Mechanism

Selection Mechanism

We will select the team based on the following Mechanism:

3 male athletes and 1 female athlete are seeded into the team:

Wu Siu Hong, Mak Cheuk Yin, Tseng Tak Hin, Chan Shuk Han (Female)

2 male team spots are available through selection qualification (objective and based only on scores or key performance indicators)

1 male team spot for open selection by coaches (Coaching staff proposes athletes in priority order who will best 'fit' in the team with the other 5 athletes)

Additionally, the open selection 'list' will have a priority order of 1,2,3,4. This will be proposed by coaching staff and taking into account unforeseen circumstances such as injury or illness.

Athletes who are invited to take part in the selection:

Wu Siu Hong, Mak Cheuk Yin, Tseng Tak Hin, Tse Chun Hin, Wong Kwan Yuen, Kwok Wing Yeung Ernest, Lui Chin Hung, Lau Kwun Ho, Yu Ho Yin, Mark Siu Ki (and Chan Shuk Han depending if we need an even number of bowlers)

Appeal Mechanism

Team List will be announced by HKTBC by **December 19, 2022, on or before 5pm**. Appeal against the non-selection may be made in writing in email to the Chairman and HKTBC by **December 20, 2022, on or before 5pm**. The sole ground for any appeal is that the selection criteria is not properly followed. Within two (2) working days of receiving the appeal, the Appeal Committee will investigate the issues of the appeal with

all involved parties. HKTBC will, in writing, inform all parties about the Appeal Committee's decision to either uphold or reject the appeal by **December 22, 2022**. The decision of the Appeal Panel will be final.

Other Points to note:

Change of Selected Athletes

An Athlete selected for the 26th Asian Championships may be deselected at any point if the athlete:

1. Due to illness or injury becomes unable to perform to the required standard in the opinion of Chairman/Head Coach
2. Demonstrates a lack of commitment to training requirement and tournament preparation in the opinion of Chairman/Head Coach
3. Breaches or fails to fulfill the requirement of the Anti-Doping Policies of Hong Kong Anti-Doping Committee/ ABF
4. Any other reason not stated above, but where change of selected athletes is deemed appropriate and approved by HKTBC Selection Committee
